

Contest Rules

1. Eligibility. Subject to the additional restrictions below, the World Beer Festival Trip Giveaway is open to U.S. residents only (excluding Puerto Rico). Must be 21 and up to enter.
2. Entry Requirements: Participant must purchase a ticket to the World Beer Festival Cleveland, at North Coast Harbor Dock 32 on July 13. Participant must be able to provide **Full name, zip code and email address** at time of ticket purchase. Multiple entries in a single period will not be accepted. Prize is non-transferable and does not have a cash value. Employees of *All About Beer Magazine*, and each of their respective affiliated companies, and the immediate family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win.
3. How To Enter. Purchase a General Admission **or** VIP Admission ticket to the World Beer Festival Cleveland at North Coast Harbor Dock 32, to be held July 13, 2013. No response by 12:00 p.m. July 12, 2013 may result in disqualification and an alternate winner may be selected from among all remaining eligible entries. Winners may waive their right to receive prizes. Prizes are nonassignable and nontransferable. No substitutions allowed by winner. Prizes and individual components of prize packages are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value.
